## Studying with Mobility Impairments

Disabilities affecting mobility can have impact on studies in various ways. Students with mobility impairments require individualized support, which will be clarified at the Disability Office following the procedures explained in the attachment of this document.

## **How Lecturers can support**

When asked, please take some time for a meeting with students with mobility disabilities.

### In the Lecture/Seminar

- Think about students in wheelchair who need not only barrier-free classrooms but also desks
  that they can drive underneath. The rooms also should have appropriate space for parking
  the wheelchair and be close to a wheelchair-accessible restroom. Hörsaalsdisposition Team
  and the Disability Office will support eagerly to find a proper classroom accessible for
  students with mobility disabilities.

- If asked, provide written drafts (slides, scripts, notes, etc.) in advance for students with
  mobility disabilities to prepare for the course. The students may have difficulties in
  coordination and become easily exhausted with writing.
- Students with mobility disabilities may need student assistants for taking notes, doing
  literature research, etc. The costs arising from this will be covered by the Disability Office and
  Disability Insurance. You can support us to find suitable assistants.
- Sometimes, recording of a session on electronic device may be necessary. To protect the
  copy right, the Disability Office will issue an agreement between you and the students with
  mobility disabilities.

### Others

- Structural conditions of buildings can hinder students with mobility disabilities from participating in internships or field trips. Please take this aspect into consideration.
- Legitimate medical absences may occur. Please have the course material available in this
  case.

## **Possible Adjustments in Coursework Assessment**

- Deadline extension for written works
- Written exams: allow to write answers with PC/Laptop instead of writing with hands, extra time, possibility to have breaks in a long exam, etc.

According to paragraph 17 "Studying with Disability" in the regulation of admission at University of Zurich stated below, the impact on study-related activities caused by health problems or impairments will be clarified at the Disability Office.

In complex situations, the lecturers and/or program coordinators concerned will join in the clarification process.

The Disability Office will document the individual adjustments in the form of CIRA<sup>1</sup>. Depending on the faculty, either the Disability Office or the student will request for the implementation of adjustments to a responsible person according to each faculty's regulation.

After the proposition has been authorized, the lecturer, the Disability Office or the student him/herself will inform of the accommodations to the responsible person.

The Disability Office will eagerly support in carrying out the measures.
